To evaluate patient's/parent's experiences with our practice and their care we performed a survey during April 2015. We analyzed the patient's responses and satisfaction. Subsequently, after this survey, we informed all our patients about PCMH rules and implementation in our practice. We have explained our roles as medical home and their roles as patients/parents in the care system. We have improved our performance in multiple settings following PCMH recommendations. We tested this improvement with follow-up surveys in July 2015. The results of both surveys are displayed below.

Based on the second survey we believe our patient's satisfaction improved from April 2015 to July 2015. We did not receive any negative evaluations in either survey or any suggestions for change. We believe that most of the patients are happy with our services. The improvement in satisfaction may be due to the increased communication and follow up that we implemented as a result of PMCH.
